**NOTIFICATION**

(A) It is notified that Annual vacations, holidays for the year 2022 and working arrangement for Special holidays for Maharashtra Administrative Tribunal, Mumbai and its Benches at Aurangabad and Nagpur shall be as follows :-

- 1) Summer Vacation shall be from 09.05.2022 to 05.06.2022. (Both days inclusive).
- 2) Diwali Vacation shall be from 24.10.2022 to 02.11.2022. (Both days inclusive).
- 3) Christmas Vacation shall be from 26.12.2022 to 01.01.2023. (Both days inclusive).

(B) The Maharashtra Administrative Tribunal, Mumbai shall observe holiday on Monday, 21<sup>st</sup> February, 2022 and Thursday, 1<sup>st</sup> September, 2022.

(C) The Maharashtra Administrative Tribunal Bench at Aurangabad shall observe holiday on Friday 25<sup>th</sup> March, 2022, Thursday, 1<sup>st</sup> September, 2022, Friday, 2<sup>nd</sup> September, 2022 and Tuesday, 4<sup>th</sup> October, 2022.


(D) The Maharashtra Administrative Tribunal Bench at Nagpur shall observe holidays on Thursday, 1<sup>st</sup> September, 2022, Friday, 2<sup>nd</sup> September, 2022, Friday, 14<sup>th</sup> October, 2022 and Monday, 7<sup>th</sup> November, 2022.
